Presentations to the Board

Jennifer Greene and Elizabeth Kerley, Appalachian District Health Department
Jennifer Greene gave a presentation on addressing the opioid crisis in Alleghany
county. She highlighted AppHealthCare's approach and grant opportunities they are
working on.

Elizabeth Kerley went over statistics across the state in comparison to Alleghany county regarding medication overdose deaths, opioids dispensed, unintentional overdose deaths, drugs to combat overdoses and 2018-2020 health priorities.

Elizabeth Kerley outlined AppHealthCare's collaboration with the Sheriff's department to implement the Emergency Overdose grant opportunity.

Commissioner Bobby Irwin said at the last board meeting with the health department, part of the 18-21 strategic plan was "to promote healthy and safe living, prevent disease, protect our environment." Commissioner Bobby Irwin asked about how this strategy aligns with the goal of the nuisance ordinance from 2018.

Jennifer Greene explained the set of remedies AppHealthCare uses when a public health hazard is reported.

Commissioner Bobby Irwin said he thinks there is a misunderstanding that the community thinks the county doesn't need an ordinance because there is a health department. He said he thinks there is a misunderstanding about what the health department does, can do and will do with regard to a nuisance.

Jennifer Greene said if there is risk to the public's health in the community, citizens are welcome to call the health department and they will investigate. She said the health department is always willing to go and look at any concern the community brings to them.

Nick Hawks, Rural Victims of Crimes grant opportunity

Nick Hawks gave update on a grant opportunity he is pursuing in 2019 for Rural Underserved Victims of Crimes which will create two non-sworn positions with the Sheriff's department.

Commissioner Prince made a motion to allow Nick Hawks to proceed with pursuing the Rural Victims of Crimes grant. Commissioner John Irwin seconded. Vote 5:0.
