Karen Evans, Finance Officer explained the need to "clean up" the commercial solid waste releases.

Commissioner John Irwin made a motion to approve commercial solid waste releases. Commissioner Larry Prince seconded. Vote 5:0.

Karen Evans asked if in the future, commercial solid waste releases could be put on the consent agenda. The board concurred.

Megan Edwards, Recreation Director

Piping creek and clearing trees at Fire Training Facility

Megan Edwards, Recreation Director explained the proposal to clear the trees 20-30 feet from Bledsoe Creek and said there is an overflow for a privately owned pond flooding the property.

Chair Bill Osborne explained the idea to pipe the overflow to Bledsoe Creek.

Megan Edwards explained there is money in the Fairgrounds Repair and Maintenance line item for this project.

Chair Bill Osborne said he spoke to the Maintenance and they can complete this project.

Commissioner John Irwin made a motion to table the fire training piping project until the March mid-month meeting. Commissioner Larry Prince seconded. Vote 5:0.

Lion's Club dirt/bank

Megan Edwards said the bank at Lion's Club has been sloped and the dirt moved to Sparta field.

Megan Edwards opened the discussion about whether more dirt needed to be removed from Lion's Club or if the board wanted to bring in 20-25 loads of gravel to expand parking.

Megan Edwards said the parking situation needs to be remedied by April to utilize the expanded parking.

Megan Edwards explained there is a culvert at the Fairgrounds that could be used at Lion's Club.

County Manager, Michael Carter asked if the board would give staff time to get some ideas together to remedy the dirt/gravel situation.

Commissioner John Irwin made a motion to table the Lion's Club dirt/bank discussion until the March mid-month meeting. Commissioner Larry Prince seconded. Vote 5:0.

Fire tax discussion

Commissioner John Irwin explained problems our volunteer fire departments are facing.

Rescue tax discussion

Commissioner John Irwin explained problems our rescue squad is facing.

Commissioner John Irwin recommended not having more than four members of the Complete Count Committee. He recommended Karon Edwards, Vickie Scott and Susan Nilo comprise the committee.

Commissioner John Irwin made a recommendation to table the Complete County Committee until the first meeting in March.

Commissioner Mark Evans said he would like more people included than the previous recommendation.
