County Manager, Michael Carter said it should be an approved use of the \$2M that may be coming from the state.

County Manager, Michael Carter said we have several big things coming up; budget, second Courtroom, fixing up our current Courthouse and he's thankful for that.

County Commissioner comments

Commissioner Mark Evans said he hopes everyone enjoys the season for what it is. He encouraged everyone to jump in since filing opened today. He thanked all staff for the positive things going on under County Manager, Michael Carter's leadership.

Commissioner Bobby Irwin congratulated the Town Chamber of Commerce on the parade. He said the hospital dedication was very nice. He wished everyone a Merry Christmas. He said Toyota Motor North America is building a major scale battery manufacturing plant in Greensboro with an investment of \$1.29B. He said the community colleges will be training employees for this plant. He asked about paving estimates at the Fairgrounds.

Commissioner John Irwin congratulated the County Manager and his staff on the audit findings. He said the wording in the Alleghany News does not reflect the actual events of awarding the telephone/internet RFP. He explained when and why governments have to bid. He said the telephone RFP met the requirements so we went out for bid. He said NCGS also says we must accept the lowest bid unless we have reasonable doubt that they can perform. He said the winning company, Ideacom, provides telephone and internet for Baptist hospital, Camp Lejune, Cherry Point, New River, Alexander County. He said Skyline is the 8th largest telephone cooperative in the nation. He wished everyone a happy holiday season. He said he enjoyed the parade on his campaign platform.

Commissioner Mechelle Luffman said she toured the hospital expansion and it's beautiful. She said she believes in the vaccine but she doesn't believe you can mandate people to have a medication put into their arm. She said everyone has to make their own personal decision about the vaccine.

Chair Bill Osborne said the hospital ceremony was very nice and there is a lot to be proud of. He said the Christmas parade was very nice and the Chamber did a great job. He said he appreciates the Rescue Squad.

Commissioner Mechelle Luffman made a motion to promote the GIS Specialist pay grade 63 to the combined GIS Administrator pay grade 70. Commissioner John Irwin seconded. Vote 5:0.

Commissioner Mechelle Luffman made a motion add the state-mandated Adult Protective Services position at DSS at grade 71A. Commissioner John Irwin seconded. Vote 5:0.

Commissioner Mechelle Luffman made a motion to increase all full-time DSS workers' salaries by a one-time \$2,000 adjustment beginning January 2022. Commissioner John Irwin seconded. Vote 5:0.

Commissioner Mechelle Luffman made a motion to increase all full-time Sheriff's office law enforcement personnel salaries by a one-time adjustment of \$2,000 beginning January 2022.

Commissioner Mechelle Luffman made a motion to increase all certified detention officers' salaries by a one-time adjustment of \$2,000 beginning January 2022. Commissioner Mark Evans seconded. Vote 5:0.
